# COCOA PRICE CROSSES ₹1K-MARK, FARMERS WAIT & WATCH

While price of dry cocoa beans rose by more than 200% from ₹325/kg in January to ₹1,020/kg last week, price of wet beans rose from ₹85/kg to nearly ₹400/kg

M C SAJU, a small farmer who grows cocoa on a four-acre plot at Koothattukulam in Ernakulam district, has spread nets on the ground beneath each cocoa tree to ensure not a single bean is lost after the squirrels spit

"The squirrels only suck out the sweet flesh. One bean fetches ₹1 at the current price," he says.

According to him, 1,000 cocoa beans would come to nearly 1,100 grams. "That's ₹1,000 plus.'

While the price of dry cocoa beans rose by more than 200% from ₹325/kg in January to ₹1,020/kg last week,

the price of wet beans increased from ₹85/kg to nearly ₹400/kg, a whopping rise of 375% in four months. The sharp increase in international cocoa prices is attributed to a collapse in production in west African countries, like Ivory Coast and Ghana, which account for 60% of global production.

For Ajit T T, the chief mar-\*Ist advance estimate keting officer of Caramin Ex-

tracts, a small cocoa-processing unit based in Chelachuvadu near Cheruthoni in Idukki district, the situation is entirely different. The company procures cocoa from a group of 200 farmers spread across the panchayats of Murickassery, Kanjikuzhy and Vathikudy.

"Every Monday we go to their homes, collect the fresh beans and give them the most premium price. We dry the beans, process them and turn them into chocolate ingredients before selling them to chocolate manufacturers. With the sharp rise in cocoa prices, there is a possibility of lower demand from chocolate companies,' reckons Ajit.

If the situation persists, he believes chocolate makers will have to either increase prices or slow down cocoa purchases.

"But the good thing now is that there is enough demand within the country that I don't see any slowdown in cocoa procurement," he adds.

His company has the capacity to process 5,000 kg of cocoa beans a month.

"After the increase in prices, we have seen farmers taking

good care of cocoa trees by pruning the leaves, protecting the fruits and watering the plants. This could result in at least a 40% increase in production," Ajit says.

K J Varghese, president of the Cocoa Producers' Cooperative Society in Manimala, Kottayam, says he sold five tonnes to Mumbai-based Morde Food Products when the price touched ₹700/kg. He sold another tonne at ₹1,000/per kg.

"Yes, the going has been good this year," says Varghese.

Cocoa farmers like Saju have never had it so good since the price boom of the early 1980s, when farmers in Kerala, mostly in Idukki, jumped into cocoa cultivation in large numbers buoyed by the sharp increase in prices. But it turned out to be a bitter experience for them as the prices collapsed soon, forcing many to destroy the crop and return to rubber. This time, Saju does not foresee a similar scenario, at least not in the immediate future even as most farmers are just watching from the sidelines. They are like "once bitten, twice shy", he the prices slowly started to

Indian chocolate makers like Morde Foods, Jindal Cocoa and Ambriona are the biggest buyers of the cocoa and its substitutes. Industry officials reckon there won't be any slowdown in demand in the near future as the supplies from Ghana and Ivory Coast will take time to return to normal. Ajit's Caramin Extracts supplies beans, roasted shell, cocoa liquor, cocoa butter and cocoa powder to chocolate makers.

According to the first advance estimate of Kochi-based Directorate of Cashewnut and Cocoa Development, the cocoa production by Kerala grew marginally to 10,535 tonnes in 2023-24 from 10,533 in the preceding year.

During the same period, the area of cocoa production increased from 18,233 hectares to 18,458 hectares. Though the increase in production may seem marginal (just 2 tonnes a year), the picture is different on a three-year perspective when climb. In 2020-21, the cocoa production in Kerala stood at 9,647 tonnes, meaning it grew by 888 tonnes or nearly 10% in three

POLICE HAVE submitted an investigation report refuting the allegations against Dr K V Preethi, a gynaecologist at Kozhikode Medical College Hospital, in the complaint filed by the medical college ICU sexual assault survivor.

Dr Preethi had recorded the victim's statement in the sexual assault case. A year ago, the survivor approached the city police commissioner, alleging that Preethi tried to protect the accused by not recording her statements fully.

Last month, the woman launched a strike in front of the commissioner's office in Kozhikode in protest against the delay in the probe. Following this, the IG North Zone assured her of police action, acting on the instructions of Chief Minister Pinarayi Vijayan.

The Medical College police shared the investigation report with the complainant two days ago.

The report states that the investigation team could not identify any motive for Dr Preethi, a relatively junior doctor, and her accompanying doctor to help anyone in the case. "Dr Preethi has written in the case sheet the same things that the complainant said during the examination. The same things have been told to the investigating officers as well. Therefore, no negligence on the part of the doctor was found and no further action is required in the complaint," said the report.

Meanwhile, the complainant expressed her dissatisfaction with the police report and questioned the addition of the name and statement of another junior doctor in the investigation report. "The name and statement of a doctor, a second year PG student, have been included in the police report now. No junior doctor came along with Dr Preethi when she examined me. That junior doctor was not a witness in any of the chargesheets filed by the police in court. I will demand a reinvestigation," said the survivor.

#### **NEET-UG:** 1.13L students attend exam in state

T'Puram: The National Eligibility cum Entrance Test (NEET)-UG exam for admission to undergraduate medical and allied courses was held in 295 centres across the state and one centre in Lakshadweep on Sunday. ## Implementation of Inland Vessels rules puts SWTD staff in a fix

THE TRANSITION from the Kerala Inland Vessel Rules 2010 to the Inland Vessel (Manning) Rules 2022, established under the Inland Vessel Act 2021 of the Union Government, has left nearly 1,000 employees in the operating division of the State Water Transport Department (SWTD) in a fix.

As per a directive from the SWTD, in compliance with the IV Rules 2022, the validity of certificates of competency and certificate of service issued to operating employees such as first and second-class boat master, serangs, engineers, engine drivers, and lascars will expire on June 6, 2024. To renew these certificates, employees must at-

tend revalidation classes and basic safety courses at their own expense, and submit course certificates before the specified date. According to employees, the cost of the training programme is reportedly substantial, leaving many employees unable to afford it. The need for revalidation

and training has created uncertainty and financial strain for many employees, highlighting the need for support and solutions to address these issues. Employees have highlighted that the training fees range from ₹5,900 to ₹14,160, depending on the position. Additionally, the training will take place at the Kerala Maritime Institute at Neendakara in Kollam, lasting anywhere from four to

13 days. Employees will also be responsible for covering the costs of accommodation during the training period. T S Suresh Babu, the general

secretary of the SWTD Employees Federation (SWTDEF), expressed concerns about the financial burden being placed on employees. "When the Kerala Inland Vessel Rule replaced the Canals and Public Ferries Rules in 2010, employees did not incur any additional expenses. The new rule should be implemented without imposing financial hardships on the employees," he said.

Babu also mentioned that some employees, like lascars, hold multiple licenses and are capable of operating boats in the absence of a serang. Renew-

ing all these licenses under the new rules would result in significant expenses for these employees.

The SWTD order mandates that station masters ensure employees' licenses are renewed in compliance with the IV Rules 2022. Station masters are also instructed to facilitate employees' participation in the training program without disrupting boat services statewide.

The Federation's office bearers recently met with Transport Minister K B Ganesh Kumar to address these concerns and submitted a petition outlining the challenges faced by employees. The minister reportedly assured the Federation of a positive response from the government.
